In keeping with our Constitution and By-laws we have the following types of membership: (Check one)

- Regular Membership - \$20.00 Per Person:** Open to all persons eighteen years of age and older, - paying annual dues and having all the privileges of Club membership.
- Household Membership - \$25.00 Per Household:** Consisting of two persons eighteen years of age and older, residing in the same household. This membership shall entitle each person to full benefit of Club membership but allow only one vote per household at Club meetings.
- Junior Membership - \$10.00 Per Person:** Open to all persons 10-17 years of age paying annual dues at one-half (1/2) the rate of a Regular Member. This type of membership shall have all the privileges of Regular Membership except the right to vote at Club meetings, hold office or serve on the Nominating Committee. At age eighteen (18) junior members are eligible for Regular Membership.
- Club Membership - \$25.00 Per Club:** This membership is for Terrier Breed Clubs, or other Terrier interest clubs, that desire a membership. It entitles the club to one (1) vote by a representative of the "member club's" choosing.

CODE OF ETHICS**

- The purpose of the Terrier Club of Michigan, Inc. is to protect, preserve and promote purebred Terriers.
- The Club members shall breed Terriers as exemplified for their breed by their official breed standard.
- The Club members shall only use for breeding adults of stable temperament, physically and mentally sound and devoid of obvious physical and known genetic defects.
- No dog or bitch shall be used for breeding, which is not properly registered.
- Members shall not sell or donate dogs or purpose to commercial dog wholesalers or retailers, or unethical breeders, not to any buyer where there is reason to believe that the puppy or dog will not be properly cared for. Further, the breeder shall not buy or sell in litter lots.
- The fancier who places a puppy shall make themselves available to the person(s) with whom the puppy is placed and shall act in an advisory capacity and provide a health guarantee.
- Club members shall not use unfair business practices and/or tactics toward the general public or fellow fanciers.
- Club members shall conduct themselves in a sportsman-like manner in the show ring and on the show environs.
- Club members shall be helpful and supportive of one another.
